## **#EmbraceEnable Photo Drawing ("Drawing")**

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCE OF WINNING.

**1. Eligibility:** Participation is open only to individual legal residents of the United States and the District of Columbia who have reached the age of majority as of the date of account opening ("Entrant"). Void where prohibited or restricted by law.
