Treasurer Stenberg Introduces Enable

Savings program for people with disabilities

In a momentous news conference Nov. 19 in the Capitol Rotunda, Treasurer Stenberg announced that Nebraska's Achieving a Better Life Experience (ABLE) program will be managed by First National Bank of Omaha and will be operational by summer 2016.



The program, which allows people with disabilities to create tax-advantaged savings accounts, will be known as the Enable Savings Plan. Stenberg said he expects the Nebraska program to be one of the first in the nation to be up and running. Residents of other states can set up accounts in the Nebraska Enable Plan.

Seventh and eighth graders are encouraged to enter the 14th annual "Why I Want to Go to College" writing contest for a chance to win a NEST scholarship and tickets to the May 1 Storm Chasers game at Werner Park in Papillion.

The annual writing contest is sponsored by the Nebraska State Treasurer's Office and the Omaha Storm Chasers. Entries are due March 18.

Three winners will be chosen in each of Nebraska's three U.S. Congressional districts, and three winners will be selected from outside Nebraska. Each first-place winner will each receive a \$2,000 contribution to a NEST college savings plan. Second-place winners will each receive a \$1,000 contribution to a NEST plan, and third-place winners will each receive a \$500 contribution to a NEST plan. Each Nebraska winner receive four tickets to the May 1 game. Encouraging Teachers, Students to Sign up for Finance Challenge 2016

Treasurer Stenberg sat down with Josh Hinrichs, business teacher at Lincoln Southwest High School, in the Drawing Room of the Governor's Residence to talk about the value of financial literacy education and to encourage Nebraska high school students to enter the Personal Finance Challenge 2016. The Nebraska Educational Savings Trust will provide \$14,000 in NEST scholarships to members of the top three team in the state competition, sponsored by the Nebraska Council on Economic Education.
